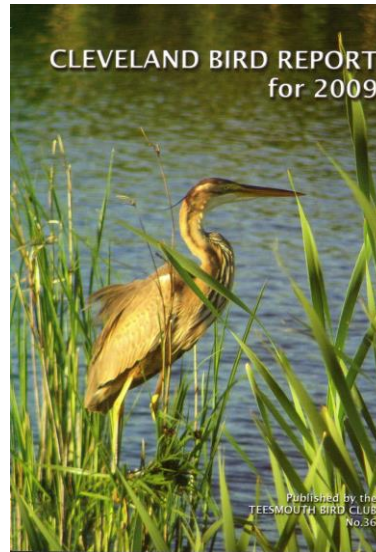


CLEVELAND BIRD REPORT
